THIS CAUSE coming on pursuant to the Order of Pre-Hearing Conference on March 12, 2013 at the Lee House, 2nd Floor Hearing Room, 422 North Blount Street, Raleigh, North Carolina at 10:00 a.m. Victoria Voight, Special Deputy Attorney General appeared as counsel for the Complainant; without objection of Complainant, Tony Edwards, owner/president of Respondent, appeared by teleconference for the Respondent.

Pursuant to the Order of Pre-Hearing Conference (the "Hearing Order") a pre-hearing conference ("Hearing") was held for the purpose of considering matters which would simplify the issues and expedite the proceedings in the above referenced case. At the Hearing Complainant and Respondent stipulated that abatement of the alleged violations has occurred based on the Respondent having closed its facility in Fairmont, North Carolina (the "Inspection Site") and Respondent having terminated its lease of such property. Respondent informed the Undersigned during the teleconference that as a result of discussions during the Hearing the Respondent wished to withdraw its Notice of Contest. Respondent verified its withdrawal of its Notice of Contest by transmitting such Notice by e-mail and by facsimile transmission. Complainant did not object to Respondent's withdrawal of its Notice of Contest.

FINDINGS OF FACT



Based on the Stipulations at the time of the Hearing and the record, the Undersigned makes the following Findings of Fact:

- 1. This Court has jurisdiction over the parties and the subject matter of this Hearing.
- 2. Respondent is subject to the provisions of the Act and jurisdiction of the Safety and Health Review Commission of North Carolina.
- 3. Neither party has any procedural objection to this Hearing.
- 4. There has been abatement of the alleged violations.

CONCLUSIONS OF LAW

The foregoing Findings of Fact are incorporated by reference as Conclusions of Law to the extent necessary to give effect to the provisions of this Order.

NOW, THEREFORE, IT IS ORDERED, ADJUDGED AND DECREED:

1. That Respondent's Motion to withdraw its Notice of Contest is hereby **GRANTED.**
