STIPULATION AND
NOTICE OF SETTLEMENT

**NOW COME** the parties in the above-captioned action, pursuant to Rule .0701 of the Rules of Procedure adopted by the Safety and Health Review Board of North Carolina, and respectfully show unto the Board as follows:

- 1. Respondent, Miller Building Corporation, has ceased business operations.
- 2. In consideration of this, the parties agree to the following resolution of the above-captioned matters:
- a) Complainant and Respondent withdraw their respective Petitions and Cross-Petitions for Review.
- b) Respondent withdraws its Notices of Contest.
- c) Complainant amends the citations by dismissing all proposed penalties.

- 3. Respondent agrees that the alleged violations in all of the above-captioned matters have been abated by the cessation of its business operations.
- 4. The parties agree to bear their own attorney's fees, costs, and other expenses that have been incurred in connection with any stage of these proceedings up to and including the filing of this Stipulation and Notice of Settlement.
- 5. The parties agree that this Stipulation and Notice of Settlement is a full and final settlement of the claims set out in all of the above-captioned Citations and Notifications of Penalty, and none of the foregoing agreements, statements, stipulations and actions taken by the Respondent shall be deemed an admission by the Respondent of any of the allegations contained in the Citations and Notifications of Penalty or waiver of defenses; provided, however, that in any subsequent proceeding with respect to matters covered by this Stipulation and Notice of Settlement brought directly under the Act by Complainant, this Agreement shall have the full force and effect of a final order. The agreements, statements, stipulations and actions herein are made solely for the purpose of settling this matter economically and amicably without further litigation and shall not be used for any other purpose except for proceedings and matters arising under the Occupational Safety and Health Act and Article 21, Chapter 95 of the North Carolina General Statutes.
- 6. Respondent has no employees for whom or business location in which to post this Notice.

**WHEREFORE,** the parties to this action hereby respectfully request approval of this Stipulation and Notice of Settlement.
