THIS MATTER is before the undersigned on Respondent's Petition for Review filed on October 4, 2024. The Petitioner seeks the Commission's review of the Hearing Examiner's Order entered on September 30, 2024, by the Honorable MARY-ANN LEON.

Complainant's petition is timely pursuant to Rule .0602. However, "only in cases of *final* orders by Hearing Examiners is the Respondent or Complainant entitled as of right to a hearing before the [Commission]." *Brooks v. H. B. Zachry Company*, 2 NCOSHD 341, 349 (RB 1982). "Orders of an interlocutory nature ... are subject to review only if the [Commission] determines a review is appropriate." *Id*.

The underlying petition raises issues related primarily to the adequacy of Complainant's service of process. The petition reveals no substantial right that will be lost absent immediate review. The Chairman has determined that interlocutory review is not warranted and, in its discretion, the Commission concurs.
